
Arabic & English

Mohamed Zain Sulaiman holds a Bachelor degree in Islamic Studies from the Islamic University of Madinah, Saudi Arabia; a Master of Science in Arabic-English Translation and Interpreting from Heriot-Watt University, Edinburgh; and a PhD degree (Translation Studies) from Monash University, Melbourne. He also holds a certificate for the memorisation of the Holy Qur'an awarded by the Qur'an Memorization Society of Makkah Al-Mukarramah, Saudi Arabia under the supervision of Imam Muhammad Bin Saud Islamic University.

Zain has been working as a professional linguist specializing in translation and interpreting since 1995. His working languages are English, Malay and Arabic. He served as Chief Translator and Interpreter and subsequently as Researcher in a diplomatic mission for eight years before joining Universiti Kebangsaan Malaysia (UKM) in 2008. Currently, he is a senior lecturer in Translation Studies and Arabic and the Head of Foreign Languages and Translation at UKM. As a professional translation practitioner, he has provided translation services for both the public and private sectors including the Malaysian Prime Minister's Department, Malaysian Institute of Translation & Books, Organization of Islamic Conference, Leo Burnett, Ogilvy & Mather, J. Walter Thompson, M&C Saatchi and many others. He was also on the Translation Committee tasked by the Department of Islamic Development, Malaysia to translate *Tafsir Pimpinan al-Rahman Kepada Pengertian al-Quran* into English.

Zain has also lectured and supervised postgraduate students in the Arabic translation stream at Monash University, Melbourne from 2011 to 2013. His doctoral research on translation won third place worldwide for the CIUTI PhD Award 2015. In January 2016, he was invited to the CIUTI Forum held at the United Nations, Geneva to present his research findings and receive the award from the CIUTI Council. He is also currently on the editorial board of two renowned international journals in the field of Language Studies namely GEMA Online® Journal of Language Studies and New Voices in Translation Studies. He also co-authored, with Rita Wilson, a book titled Translation and Tourism: Strategies for Effective Cross-Cultural Promotion published by Springer in 2019.
